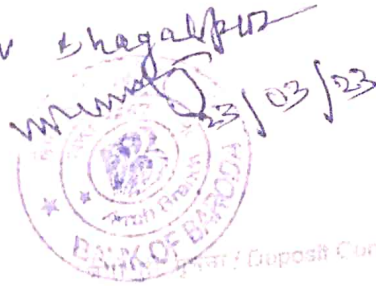

अवरोध व शर्तें/Terms & Conditions:

1. Rate of Interest is in percentage per annum.

2. Automatic Renewal Clause :

3. For Deposits issued for a period of 1 year and above, Deposits will be renewed for 1 year at the prevailing rate of interest on the due date if not instructed otherwise.

4. For Deposits issued for a period of less than 1 year, Deposits will be renewed for the same period at the prevailing rate of interest on the due date if not instructed otherwise.

5. Form 15G and 15H is applicable to Resident accounts only.

6. A fresh 15G/ 15H/ 15AA (if applicable) has to be submitted by Resident individuals for each Financial Year, prior to crossing the threshold limit, failing which TDS will be deducted.

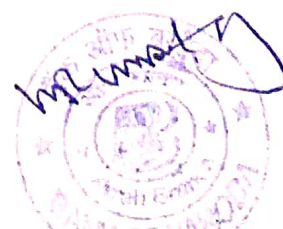
7. Form 15H can be accepted only from senior citizens (age of 60 years or more)

8. Premature Withdrawal Clause :

9. Premature withdrawal of deposit upto 1 crore will attract 1% penalty i.e. 1% less than card rate as on the date of deposit, for the period for which deposit has remained with Bank.

10. Premature withdrawal of deposit above 1 crore will attract 1.5% penalty i.e. 1.5% less than card rate as on the date of deposit, for the period for which deposit has remained with Bank. For premature withdrawal of deposit above 1 crore, a withdrawal notice of minimum 31 days prior to withdrawal of deposit is to be given to Bank.
