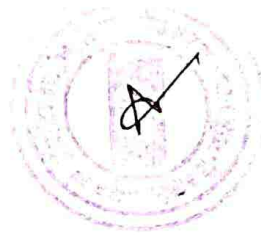

We refer to the Contract Agreement (hereinafter called the —Contract) Reference No...**258** dated **20/02/2024** between You and **M/s. Mantu singh**(Name of the Contractor) (hereinafter called the —Contractor) for the design, civil, manufacture, supply of plant & equipment, structures, storage, insurance & handling, erection, testing, commissioning and performance.

Guarantee tests of **Contract no.258 dated 20/02/2024 for Construction & Five year maintenance of Tender title :-MR-N/2023-24 Hilsa/09 (Name of Facilities)**

Whereas the Contractor has undertaken to produce a Bank guarantee under the Contract including any amendment thereto, to secure its obligations to you for the performance of the Contract including the guarantees and warranty of the Facilities & the equipment supplied.

1. We, Canara Bank, a body of corporate under the Banking Companies (Acquisition & Transfer of undertakings) Act, 1970 having its head Office at No. 112, JC Road, Bengaluru and one of its offices at Hilsa, Nalanda -801302 (hereinafter referred to as "the Bank") **(Name of the Bank)** do hereby expressly irrevocably and unreservedly undertake to unconditionally pay to you merely on your written demand, without referring it to the contractor and without protest and demur an amount not exceeding **1505000.00 (Fifteen Lakhs Five Thousand Only) (currency and amount)**. Any such demand made on us shall be conclusive as regards the amount due and payable by us under this guarantee/ any extension thereto. However, our liability under this guarantee shall be restricted to an amount not exceeding **15,05,000.00**

2. This Guarantee shall be operable / encashable at **CANARA BANK** (Name of Bank), Hilsa. (Branch),

3. Notwithstanding anything to the contrary we agree that your decision as to whether the Contractor has committed a breach of any terms and conditions of the contract shall be final and binding on us and we shall not be entitled to ask you to establish your claim or claims under this Guarantee but shall pay the same forthwith without any objection or excuse.

4. We undertake to pay to you any money so demanded notwithstanding any dispute or disputes raised by the Contractor(s) / supplier(s) in any suit or proceeding pending before any court or Tribunal or arbitration relating thereto, our liability under these presents being absolute and unequivocal.

The payment so made by us under this Guarantee shall be a valid discharge of our liability for payment thereunder.

5. This guarantee shall come into force from the date of issue of this guarantee and shall remain irrevocably valid and in force initially upto **15/05/2025** and the same may at bank's option be extended further until the expiry of the Defect Liability Period of the said Contract.

6. This guarantee shall not in any way be affected by you taking any securities from the Contractor or by the winding up, dissolution, insolvency or death as the case may be of the Contractor. We shall not be entitled to proceed against the assets of the Contractor at your site.

7. In order to give full effect to the Guarantee herein contained, you shall be entitled to act as if we were your principal debtors in respect of all your claims against the Contractor, hereby guaranteed by us as aforesaid and we hereby expressly waive all our suretyship and other rights, if any, which are in any way inconsistent with the above or any other provisions of this Guarantee.

8. This guarantee is in addition to any other guarantee or guarantees given to you by us.

9. This guarantee shall not be discharged by any change in the constitution of the Contractor or us, nor shall it be affected by any change in your constitution or by any amalgamation or absorption thereof or therewith but will ensure for and be available to and enforceable by the absorbing or amalgamated company or concern.

10. Our liability under this guarantee is restricted upto a sum **1505000. (Fifteen Lakhs Five Thousand only) (currency and amount)** and shall expire on **15/05/2025** unless a claim or demand is made on us in writing within the expiry date i.e. **15/05/2025** all your rights shall be forfeited and we shall stand relieved and discharged from our liabilities hereunder.

11. We, the said Bank confirm that the Signatory (ies) of this Guarantee is/are authorized to issue this Guarantee on behalf of the Bank and the Bank undertakes the full responsibility to this effect.
