

Revised MBD Agreement

This agreement, made the 23rd day of January 2023, in continuation of Agreement no.-07(MBD)/2022-23 between Executive Engineer, R.W.D.(W) Division, Sheikhpura cum PiU, BRRDA (hereinafter called "the Employer") of Sri Rajeev Kumar, At-K-125, P.C. Colony, Hanuman Nagar, Kankarbagh, Patna (Bihar). (hereinafter called "the Contractor"). Whereas the Employer is desirous that the Contractor execute Construction of Road and CD Works with maintenance for T01 Bhadaus More To Koyla Path [name and identification number of Contract] (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and routine maintenance of the works for 5 years and the remedying of any defects therein at a cost of Rupees 5,55,24,413/- (Rs. Five Crore Fifty Five Lacs Twenty Four Thousand Four Hundred Thirteen) and Rupees.1,28 12,997/- (Rs.One Crore Twenty Eight Lacs Forty Two Thousand Nine Hundred Ninety Seven Only.) as per revised BOQ approved by S.E., R.W.D. (W) Circle, Munger vide letter no.-45 (Enci). dt.11.01.2024 respectively.

NOW THIS AGREEMENT WITNESSETH as follows:

The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
