

Whereas the employer was desirous that the contract or execute the Construction of Road from i) Dhoriya Punsia Road To Katia (ii) BGP Dumka Road to Bakhadda Bela (iii) BGP Dumka Road To Sohani (MR-N/22-23 Banka-2/18) Year 2022-2023 under Head 3054 MR Yojna, (Tender ID-120984) Block-Rajoun District-Banka, Bihar under Rural Works Department Govt. of Bihar, Chief Engineer -2 Patna Letter No.-1875 (Attach) Dated 30.12.2022 and the Employer had accepted the Bid by the contractor for the execution and completion of Such works and the Routine maintenance of works for Five Years of the Contract Price remedying of any defects therein, at Construction Cost Rs. 11640977.00 & Maintenance Cost Rs. 1982549.00 with a Total Amount of Rs. 1,36,23,526.00 (Rupees One Crore Thirty Six Lacs Twenty Three Thousand Five Hundred Twenty Six Only) at bidder rate quoted 13.52% (Thirteen point Fifty Two Percent) below the estimated Cost.
