



We further agree that no change or addition to or other modification of the terms of the contract documents which may be made between you and the contractor/manufacturer shall in any way release us from any change, addition or modification.

We State Bank Of India ,SME Branch, Ara further agree that the guarantee herein contained shall remain in full force And effect during the period that would be taken for the performance of the said agreement and that is shall continue to be enforceable till all the dues of the Government under or by virtue of the said Agreement have been fully paid and its claims satisfied or discharged or till 22/09/2023 office/department/ RWD, W.D. Triveniganj certifies that the terms and condition of the said Agreement have been fully and properly carried out by the said Contractor/Manufacturer and accordingly discharge this guarantee .
