

## Supplementary Agreement No:-13SBD/2024-25

Whereas the Employer is desirous that the Contractor execute "Const. and Maintenance of Road from Simraha To Markariya Bari School Under MMGSY(SC) (hereinafter called "the Works") and the Employer has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein at a cost of Rs. 5,27,036,00 (Rupees Five Lacs Twenty Seven Thousand Thirty Six Only). The revision has been effected due to revision of G.S.T. (from 12% to 18%) for the above said work. All other conditions shall remain the same as before. (Main Agreement Amount - Rs. 1,46,82,600.00 vide Agreement No.- 67SBD/2020-21(Revised))
