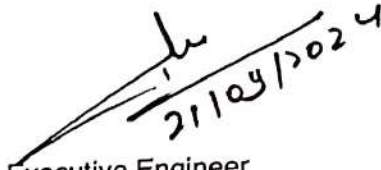
Kind of Checks exercised:-
