Works Division, Biharsharif (Nalanda) [name of Employer] (hereinafter called "the Employer") in the sum of 25,92,082/ (Twenty Five Lakh Ninety Two Thousand and Eighty Two Only)*for which payment well and truly to be made to the said Employer by the Bank itself, his successors and assigns by these presents.

- (1) If after Bid opening the Bidder withdraws his bid during the period of Bid validity specified in the Form of Bid.

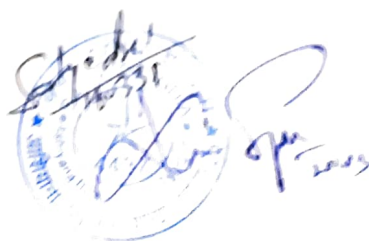

 - (b) fails or refuses to furnish the Performance Security, in accordance with the Instruction to Bidders; or
 - (c) does not accept the correction of the Bid Price pursuant to Clause 27.

We undertake to pay to the Employer up to the above amount upon receipt of his first written demand, without the Employer having to substantiate his demand, provided that in his demand the Employer will note that the amount claimed by him as due to him owing to the occurrence of one or any of the three conditions, (specifying the occurred condition or conditions).

This Guarantee will remain in force up to and including the date 12-08-2025 days after the deadline for submission of Bids as such deadline is stated in the Instructions to Bidders or as it may be extended by the Employer, notice of which extension(s) to the Bank is hereby waived. Any demand in respect of this guarantee should reach the Bank not later than the above date.

Notwithstanding anything contained herein above our liabilities under this guarantee is restricted to **Rs. 25,92,082/- (Rupees Twenty Five Lakh Ninety Two Thousand Eighty Two only)** in said bank guarantee and valid upto 12-08-2025.
