 - (11) Any other relevant documents listed in the Particular Conditions together with any post bid correspondence.

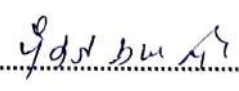

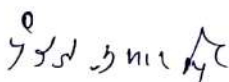

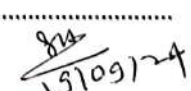
