This agreement made the 23th day of July..... 2023, between Executive Engineer, Rural Works Department (Govt. of Bihar) Works Division Madhepura (Hereinafter called "the Employer") of the one part, and Shri Arun Kumar, At- Gohumani, Singheshwar, Dist.- Madhepura (Bihar). (Hereinafter called "the contractor" of the other part) Whereas the employer is desirous that the Contractor execute the construction and five year maintenance of road under MMGSY (NDB), Construction of Road from Suresh Singh House To Hata Tola Under Package No.- MMGSY (Awsesh)-NDB-BRRP2-525-MADHEPURA; (Tender-ID-131682) (Bid ID-574610) (hereinafter called "the Works") and the employer has accepted the Bid by the Contractor for the execution and completion of such Works and the remedying of any defects therein at a total cost of Rupees 1,18,820.00 (Rupees One lakh Eighteen Thousand Eight Hundred Twenty Only)
