This Agreement made the 8th day of Aug, 2025 Between The Executive Engineer, Rural Works Department, Works Division Madhepura (The Employer) of the one part and M/S Jai Mata Di Construction, At- Gamhariya, Rampur, Baijnathpur, Dist- Saharsa Contractor of the other part. Whereas the Employer is desirous that the Contractor execute output and performance based Rural Road contract for construction and maintenance of Road under MMGSY-Gen- Construction of Kumarkhand Jorawarganj WB Road via Mirain Tola To Israinkala & 01No. HL Bridge 4x14.5 m Span at Ch. 4400 m Road; (Tender ID-116418) (Bid ID-501215) hereinafter called ("The works") and the Revised of GST claim approved by the Additional Chief Executive Officer -Cum- Secretary, BRRDA, Patna, stated as follows at a contract price of Rs 7,18,735.00 (Rupees Seven Lakhs Eighteen Thousand Seven Hundred Thirty Five Only)

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expression shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all aspects with the provisions of the Contract.
3. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein and undertaking routine maintenance for 5 years, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.




