

Whereas the Employer is desirous that the Contractor execute output and performance based Rural Road contract for construction and maintenance of Road under MMGSY-Gen- Construction of Reo Road Puraini To Mahmud Rahmani Tola & 01 No. HL Bridge 4x14.5 m Span at Ch. 1750 m; (Tender ID- 116420) (Bid ID-501217) hereinafter called ("The works") and the Revised of GST claim approved by the Additional Chief Executive Officer -Cum- Secretary, BRRDA, Patna, stated as follows at a contract price of Rs 7,44,691.00 (Rupees Seven Lakhs Forty Four Thousand Six Hundred Ninety One Only)

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expression shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to be read and construed as part of this Agreement.
2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all aspects with the provisions of the Contract.
3. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein and undertaking routine maintenance for 5 years, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.


