This Agreement made the 8th day of Aug. 2025 Between The Executive Engineer, Rural Works Department, Works Division Madhepura (The Employer) of the one part and M/S Jai Mata Di Construction, At- Gamhariya, Rampur, Baijnathpur, Dist- Saharsa Contractor" of the other part. Whereas the Employer is desirous that the Contractor execute output and performance based Rural Road contract for construction and maintenance of Road under Package No.- MMGSY-WB-19-Madhepura/04; (Tender ID-96958) (Bid ID-423454) hereinafter called ("The works") and the Revised of GST claim approved by the Superintendent Engineer, RWD, Works Circle Madhepura, stated as follows at a contract price of Rs 22,17,270.00 (Rupees Twenty Two Lakhs Seventeen Thousand Two Hundred Seventy Only) Details of Roads are as follows-

 - vii) Section IV - Works Schedule
 - viii) Quality Plan for Output and Performance Based Road Contract as per Clause A14.1 of the Technical Specifications;
 - ix) Appendices to the Contract;
 - x) Addenda issued during bid period; and
 - xi) Any other relevant listed in the Particular Conditions together with any post bid correspondence.


