This agreement made the ...13 th. day of August' 2025, between The Executive Engineer, Rural Works Department (Govt. of Bihar) Works Division Madhepura ["The E/I"] of the one part, and Nandani Construction, Prop. Shri Ashok Kumar, S/O Mundrika Ram, At- Karman Tola Ara, Ps.- Nawada Ara, Arrah, Dist-Bhojpur (Bihar)- 802301. ["The Contractor"] of the other part.

 other sum as may become payable under the provisions of the contract at the times and in
 the manner prescribed by the Contract.
