


This Agreement made the day of 2025 Between The **Executive Engineer, Rural Works Department, Works Division Madhepura** (The Employer) of the one part and **Bhupendra Yadav, At+Po- Aina, Mahishi, Dist- Saharsa (Bihar)** (Hereinafter called "the contractor" of the other part) Whereas the employer is desirous that the Contractor execute the construction and five MMGSY- New; Madhepura Saharsa (NH107) Mathahi Pokhar To Godhiyari Tola Road; (Tender ID-55071) (Bid ID-231464) hereinafter called ("The works") and the Revised of GST claim approved by the Additional Chief Executive Officer -Cum- Secretary, BRRDA, Patna, stated as follows at a contract price of Rs 7,44,037.00 (Rupees Seven Lakhs Forty Four Thousand Thirty Seven Only)

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expression shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all aspects with the provisions of the Contract.

The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein and undertaking routine maintenance for 5 years, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

 - ix) Appendices to the Contract;
 - x) Addenda issued during bid period; and
 - xi) Any other relevant listed in the Particular Conditions together with any post bid correspondence.
