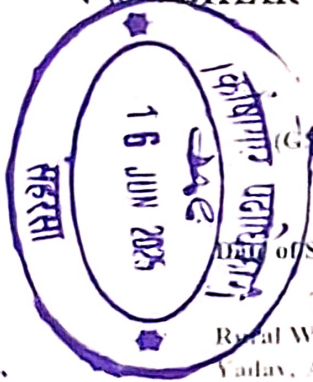

This Agreement made the day of 2025 Between The Executive Engineer, Rural Works Department, Works Division Madhepura (The Employer) of the one part and Bhupendra Yadav, At-Po- Aina, Mahishi, Dist- Saharsa (Bihar) (Hereinafter called "the contractor" of the other part) Whereas the employer is desirous that the Contractor execute the construction and five Chitti Chikanotawa Path Deepnarayan Fauji Ke Ghar To Wali Tola Road; (Tender ID-65428) (Bid ID-297000) hereinafter called ("The works") and the Revised of GST claim approved by the Additional Chief Executive Officer -Cum- Secretary, BRRDA, Patna, stated as follows at a contract price of Rs 79,751.00 (Rupees Seventy Nine Thousand Seven Hundred Fifty One Only)

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expression shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all aspects with the provisions of the Contract.

- xi) Any other relevant listed in the Particular Conditions together with any post bid correspondence.


