
NOW THIS AGREEMENT WITNESSTH and the parties hereto agree as follows :

2. In Consideration of the payments to be made by the E/I to the Contractor as hereinafter mentioned the Contractor hereby covenants with the E/I to execute and complete the Works and Services and remedy any defects therein in conformity in all aspects with the provisions of the Contract.
3. The E/I hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
