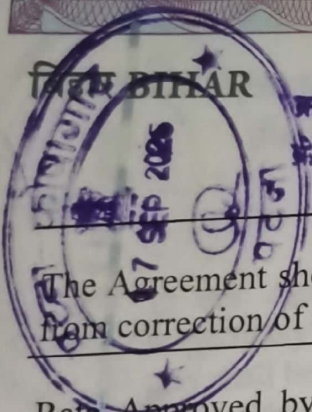
NOW THIS AGREEMENT WITNESSETH as follows,
