Under Construction and 06 years Maintenance work (output and performance based) for Rural Road/Bridge under component of Mukhya Mantri Gram Sampark Yojana (AWSESH-SC), maximum number of packages awarded in one financial year is limited to 05 (Five) even though the bidder has the available bid capacity as per ITB clause-4.6. In case a substantially responsive bidder is lowest in more than 05 (Five) packages, then 05 (Five) packages shall be awarded as per as ascending order of quoted rate [for example if rate quoted are (-)02%, (-)05%, (-)07%, (-)12%, equal to BOQ rate & (+)1%, then first of all that package shall be awarded to the bidder in which he has quoted (-)12%, (-)07%, (-)05%, then (-)02% and so on].
