This agreement, made the 25th April 2017, between Rural Works Department (Govt. of Bihar) Works Division Madhepura (Hereinafter called "the Employer") of the one part, and Shri Bhupendra Yadav, At + Po-Aina, Mahishi, Dist- Saharsa. (Hereinafter called "the contractor" of the other part) Whereas the employer is desirous that the Contractor execute the construction and five year maintenance of road under MMGSY (New), Construction of Road and CD of Baijnathpur Lithiyahi Path Se TO Gonaha Tola Via Sakhuwa Bhut (Gen) (Bid Id: 161099 for Tender ID: 43753) (hereinafter called "the Works") and the employer has accepted the Bid by the Contractor for the execution and completion of such Works and the Routine maintenance of the work for 5 years of the contract price and remedying of any defects therein at a cost of Rupees 1,58,50,217.00 (One Crore Fifty Eight Lakh Fifty Thousand Two Hundred Seventeen only).
