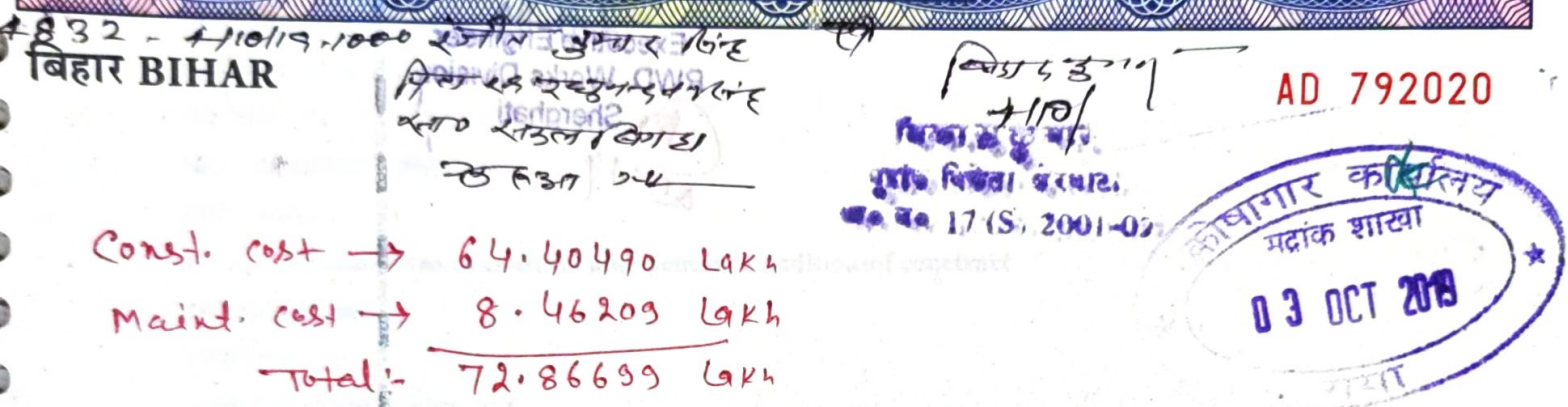
अतः अनुरोध है कि उक्त राशि में सुधार करने की कृपा की जाए ताकि अग्रेतर कार्रवाई की जा सके।
