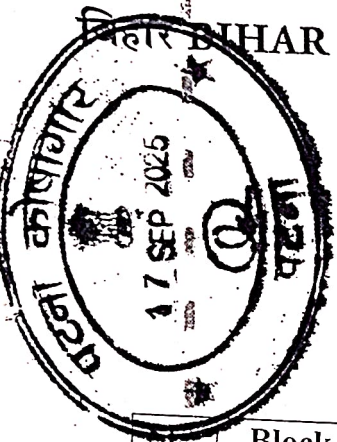


## AGREEMENT FORM
