

NOW THIS AGREEMENT WITHNESSETH as follows:

1. In this Agreement, words and expression shall have the same meaning as are respectively assigned to them in the conditions of contract hereinafter referred to and they shall be deemed to form and be read and construed as a part of this Agreement.

2. In consideration of the payment to be made by E/I to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the E/I to execute and complete the Works & Services and remedy any defects therein in conformity in all aspects with the

provisions of the contract.

3. The E/I hereby covenants to pay the contractor in consideration of the Execution and completion of the Works and remedying the defects wherein Contract price or such other sum as may become payable under the provision of the Contract at the times and in the manner prescribed by the Contract.
