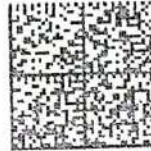

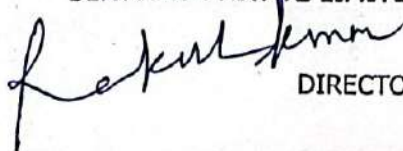
NOW THIS AGREEMENT WITNESSETH and the Parties hereto agree as follows:
