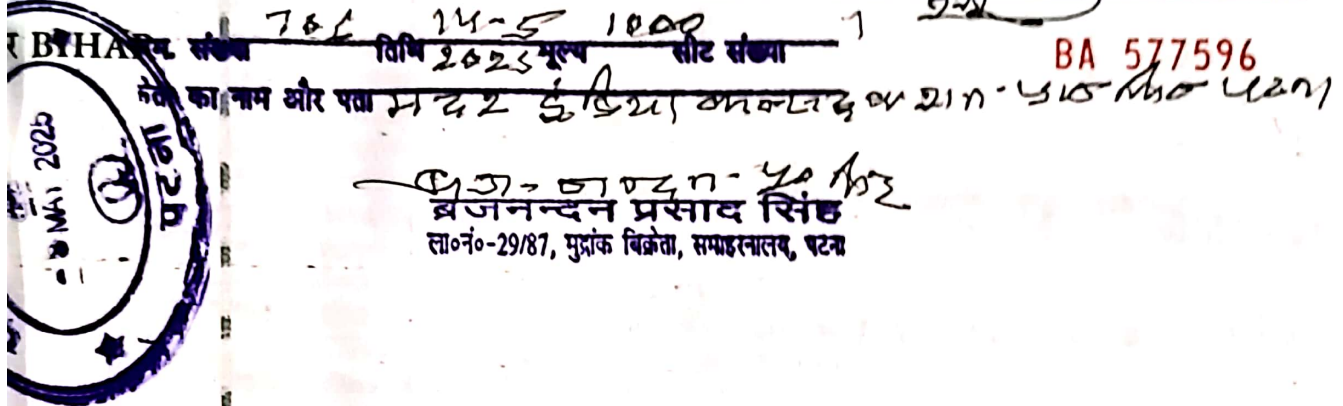

 - xi. Any other relevant documents listed in the Particulars Conditions together with any post bid correspondence.

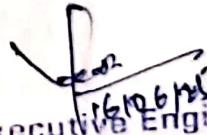
