- 3. The Employer hereby covenants to pay the Contractor in consideration or the execution and completion of the works and the remedying the defects wherein and undertaking routine maintenance for five year, the contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.
