5.Deduction:-I.T Vat/gst, Royalty & all other deduction will be deduced from each bill as per Govt. rule.

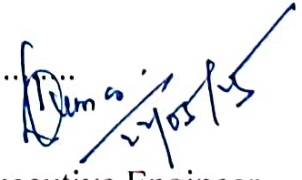
