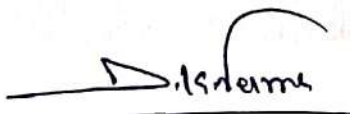

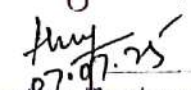

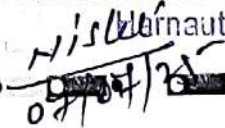

NOW THIS AGREEMENT WITNESSETH as follows and the Parties hereto agree as follows:

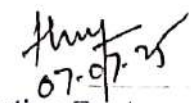
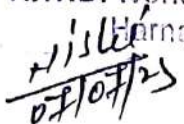
