(MMGSY-Gen) (Block-Barsoi) and the thereafter undergtake routine maintenance for five years and the Employer has accepted the Bid by the Contractor for the execution and completion of such works and the remedying of any defects and routine maintenance therein, at a cost of Rs.- 1,48,32,402.00 (One Crore Forty Eight Lakh Thirty Two Thousands Four Hundred Two Rupees) Only. The Supplementary Agreement Amount to Rs. 5,14,223.00 (Five Lakh Fourteen Thousands Two Hundred Twenty Three Rupees) Only.

The Employer hereby covenants to pay the Contractor in consideration or the execution and completion of the works and the remedying the defects wherein and undertaking routine maintenance for five year, the contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.

 - i) Letter of Acceptance;
 - ii) Notice to Proceed with the works;
 - iii) Contractor's Bid;
 - iv) Contract Data;
 - v) Special Conditions of contract;
 - vi) General Conditions of Contract;
 - vii) Specifications;
 - viii) Drawings;
 - ix) Bill of Quantities; and
 - x) Any other documents listed in the contract Data as forming part of the contract.
- 5. Deduction :- I.T., GST, Royalty & all other deduction will be deducted from each bill as applicable.
