

This agreement, made the 24th day of June 2025, between Executive Engineer Rural Works Department Works Division Madhepura (Hereinafter called "the Employer") of the one part, and Gobind Kumar, At.- Jaipalpatti, Ward No. 14 Madhepura, Dist- Madhepura (Hereinafter Called "the contractor" of the other part) Whereas the employer is desirous that the GST Claim of Contractor to execute the construction and five year maintenance of road from NH 107 Parwa Nahar Devanrahi To Tamaut Parsa Daroga ji Tola Road (MMGSY-WB) [Tender Id: 85574; Bid Id: 383466] (hereinafter called "the Works") and the employer has accepted the Bid by the Contractor for the execution and completion of such Works and the Routine maintenance of the work for 5 years of the contract price and remedying of any defects therein at a cost of Rs. 12,25,307.00 (Twelve Lakhs Twenty Five Thousand Three Hundred Seven Only)

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS :

1. In this agreement, words and expressions shall have the same meaning as are respectively assigned to them in the conditions of Contact hereinafter referred to, and they shall be deemed to form and be read and construed as part of the agreement.
2. In consideration of the payment to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the employer to execute and complete the works and remedy any defects therein in conformity in all aspects with the provisions of the Contract.


