Supplementary Agreement

This agreement, made the 24th day of June 2025, between Executive Engineer Rural Works Department Works Division Madhepura (Hereinafter called "the Employer") of the one part, and Anuj Kumar, At- Sripur, Sripur Dakshinbari, Madhepura, Dist- Madhepura (Hereinafter Called "the contractor" of the other part) Whereas the employer is desirous that the GST Claim of Contractor to execute the construction and five year maintenance of road from PMGSY Road No. 02 Bishundev Yadav Ke Ghar To Harijan Tola Road (MMGSY-SC) [Tender Id: 85574; Bid Id: 383466] (hereinafter called "the Works") and the employer has accepted the Bid by the Contractor for the execution and completion of such Works and the Routine maintenance of the work for 5 years of the contract price and remedying of any defects therein at a cost of Rs. 2,20,573.00 (Two Lakhs Twenty Thousand Five Hundred Seventy Three Only)
