Any demand in respect of this guarantee should reach the Bank not later than the above date.

Notwithstanding anything contained herein above our liability under this Bank Guarantee is restricted to **Rs. 10,86,000/- (Ten Lakh Eighty Six Thousand Only)** and this Bank Guarantee is valid up to **11.10.2024** and we shall be released and discharged from all liabilities hereunder unless a written claim for payment under this guarantee is lodged on from the date of issue of the guarantee i.e. on or before **11.10.2024** irrespective of whether or not original guarantee is returned to us.
