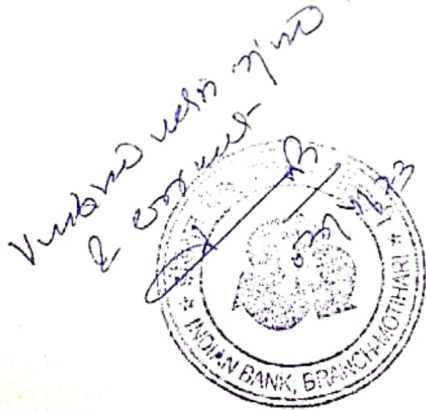

- (c) does not accept the correction of the Bid Price Pursuant to Clause 27.
