

Supplementary Agreement Form

This Supplementary agreement, made the 15 April 2025 between Executive Engineer, Rural Works Division, Hajipur of the one part Arpit Engicon Pvt. Ltd., Dighi Kala, Hajipur Dist. Vaishali. desirous that the Contractor execute the Work Const. of road from, Dighi Purvi Ramdev Chowk Sagar-Singh House to Yadav Tola (Scheme MMGSY Awsesh) and thereafter undertake routine maintenance for five Years; and the Employer has accepted the Bid by the Contractor for the execution and completion of such works and the remedying of any defects and routine maintenance therein at a cost of Rupees 270.60498 Lac (Two Seventy lac Sixty thousand four hundred ninety eight) Only.

NOW THIS AGREEMENT WITNESSETH as follows:

1. In this Agreement, words and expression shall have the same meanings as are respectively assigned to them in the conditions of contract hereinafter referred to, and they shall be deemed to form and be read and construed as part of this Agreement.
2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mention, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all aspects with the provisions of the Contract and undertaking routine maintenance for five years.
