If the Performance Security & Additional Performance Security is in the form of a Electronic Bank Guarantee. However, You would get this Bank Guarantee extended in such a way that an amount equal to the requisite Performance Security is always available with Employer until 45 days after the lapse of Defect Liability Period; failing which action as stated in Cl.30.3 of ITB will be taken.
