

The date of completion will be **12 (Twelve)** month from issue of this notice to proceed with the work.







Failing which action as stated in Cl. 30.3 of ITB will be taken. In any circumstances no construction work will be done on private & forest Land during execution of this work. You are directed to provide insurance in the name of employer (Executive Engineer) and yourself an insurance cover from the dated of start of work to the end of the defect of liability period equivalent to the amounts and deductible shown in contract data.
