

2.In consideration of the payments to be made by the E/I to the Contractor as herein after mentioned, the Contractor hereby covenants with the E/I to execute and complete the Construction Works & Routine Maintenance and remedy any defects therein in conformity in all aspects with the provisions of the contract.

3. The E/I hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein the contract price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.

4. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:

(i) Letter of Acceptance, (ii) Contractor's Bid (iii) Section VI – General Conditions,

(iv) Section VII – Particular Conditions (v) Section V – Technical Specifications (General and Supplementary Technical Specifications) (vi) Appendix A – Drawings

Based Road Contract as per Clause A14.1 of the Technical Specifications (ix) Appendices to the Contract (x) Addenda issued during bid period

Any other relevant documents listed in the Particular Conditions together with any post bid correspondence.
