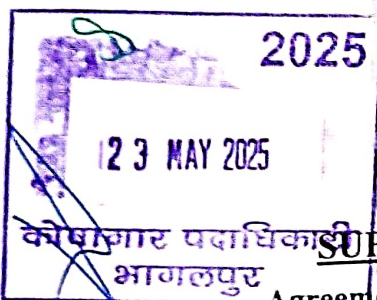

SUPPLEMENTRY AGREEMENT FOR AGREEMENT

Agreement No.- 61 S.B.D. day of year- 2021-22

This Agreement, made the 28... date of August 25, between the Executive Engineer, RWD Works Division Manihari, District- Katihar on behalf of Government of Bihar (hereinafter called 'The Employer') on the one part and Neha Enterprises, Sahu Tola, Naugachiya Bhagalpur. (hereinafter called 'The Contractor' on the Other Part).

Whereas the Employer desirous that the contractor execute "S09 Gedabari Paschim Tola" Under MMGSY (here in after called "the Works") and the Employer has accepted the Bid by the Contractor for execution and completion of such work and remedying of any defects therein at a cost of Rs.- 2,00,61,138.00 (Two Crore Sixty One Thousand One Hundred Thirty Eight Only) The revision has been effected due to revision of G.S.T. (from 12% to 18%) for the above said work. All other condition shall remain the same as before. (Main Agreement Amount Value- 1,90,58,800.00 Vide Agreement No.- 61/SBD/2021-22)

NOW THIS AGREEMENT WITNESSETH as follow

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to , and they shall be deemed to form and be read and construed as part of this Agreement.
2. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the works and remedy and defects therein in conformity in all aspects with the provisions of the Contract and undertaking routine maintenance for five years.
3. The Employer hereby covenants to pay the Contractor in consideration or the execution and completion of the works and the remedying the defects wherein and undertaking routine maintenance for five year, the contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.
4. The following documents shall be deemed to form and be read and construed as part of this Agreements, viz:
 - i) Letter of Acceptance;
 - ii) Notice to Proceed with the works;
 - iii) Contractor's Bid;
 - iv) Contract Data;
 - v) Special Conditions of contract;
 - vi) General Conditions of Contract;
 - vii) Specifications;
 - viii) Drawings;
 - ix) Bill of Quantities; and
 - x) Any other documents listed in the contract Data as forming part of the contract.
5. Deduction :- I.T., Vat, Royalty & all other deduction will be deducted from each bill as applicable.

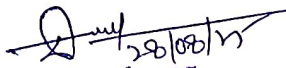
