Supplementary Agreement

(GST Claim approved by C.E.O. BRRDA, Patna vide Lt. No. 2286 Anu., Dated 18.06.2025)

This agreement, made the 2025, between The Executive Engineer, Rural Works Department (Govt. of Bihar) Works Division Madhepura (Hereinafter called "the Employer") of the one part, and Laxmi Narayan, At- Moura Ramnagar Ward No. 07, Ps- Shankarpur, Dist- Madhepura. (Hereinafter called "the contractor" of the other part) Whereas the employer is desirous that the Contractor execute the construction and five year maintenance of road under MMGSY (Sc), Construction of Road and CD of Nahar Se Purab Bhelwa Sima To Mandal Tola (Tender-ID- 84127) (Bid ID- 379329) (hereinafter called "the Works") and the employer has accepted the Bid by the Contractor for the execution and completion of such Works and the Routine maintenance of the work for 5 years of the contract price and remedying of any defects therein at a cost of Rupees 1,84,373.00 (Rupees One lakh Eighty Four Thousand Three Hundred Seventy Three Only)

The employer hereby covenants to pay the contractor in consideration of the execution and completion of the works and the remedying the defects wherein the contract price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the Contract.

 - ii. Notice to proceed with the works;
 - iii. Contractor's Bid;
 - iv. Contract Data;

 - viii. Bill of Quantities; and
 - ix. Any other document listed in the contract data as forming part of the contract.
