### Supplementary Agreement

This agreement, made the ..... 2025, between The **Executive Engineer, Rural Works Department (Govt. of Bihar) Works Division Madhepura** (Hereinafter called "the Employer") of the one part, and **Laxmi Narayan, At- Moura Ramnagar Ward No. 07, Ps- Shankarpur, Dist- Madhepura.** (Hereinafter called "the contractor" of the other part) Whereas the employer is desirous that the Contractor execute the construction and five year maintenance of road under MMGSY (Sc), Construction of Road and CD of MMGSY Path Shankarpur Birali Road To Rajkiya Madhya Vidyalay Jirwa Paschim via Road To Jirwa Madheli Road (Tender-ID- 383110) (Bid ID- 85555) (hereinafter called "the Works") and the employer has accepted the Bid by the Contractor for the execution and completion of such Works and the Routine maintenance of the work for 5 years of the contract price and remedying of any defects therein at a cost of **Rupees 4,36,515.00 (Rupees Four lakh Thirty Six Thousand Five Hundred Fifteen Only)**




