You are hereby requested to furnish Performance Security, (and additional security for unbalanced bids in terms of ITB Clause 26.3) [where applicable] in the form detailed in Cl, 30 of ITB for an amount of Performance Security **Rs. 1.20500 Lakh & Additional Performance Security Rs.- 13.67000 Lakh (Total- Rs 1.20500 + 13.67000 = 14.87500 Lakh)** within 10 days from the receipt of this Letter of Acceptance valid up to 45 days from the date of expiry of Defects Liability Period i.e. up to 01.07.2030 and accordingly sign the Contract. If the Performance Security is in the form of a Bank Guarantee, the period of validity of Bank Guarantee could be one year initially. However, You would get this Bank Guarantee extended in such a way that an amount equal to the requisite Performance Security is always available with Employer until 45 days after the lapse of Defect Liability Period; failing which action as stated in Cl.30.3 of ITB will be taken.
