This Agreement, made the 18th day of September-2025, Between The Executive Engineer, R.W.D. Works Division, Supaul ("The E/I") of the one part, and Ashish Ranjan, S/o- Amar Kumar Singh, At-Nagar Parishad, Vidyapuri, Ward No-2, Supaul (Registration No.- MD/BSEIDCL1526/2024 of Bihar State Infrastructure Class-I PAN No- AIRPR2731E) (hereinafter called "the contractor" of the other part).

The E/I hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying the defects wherein the contract price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.
