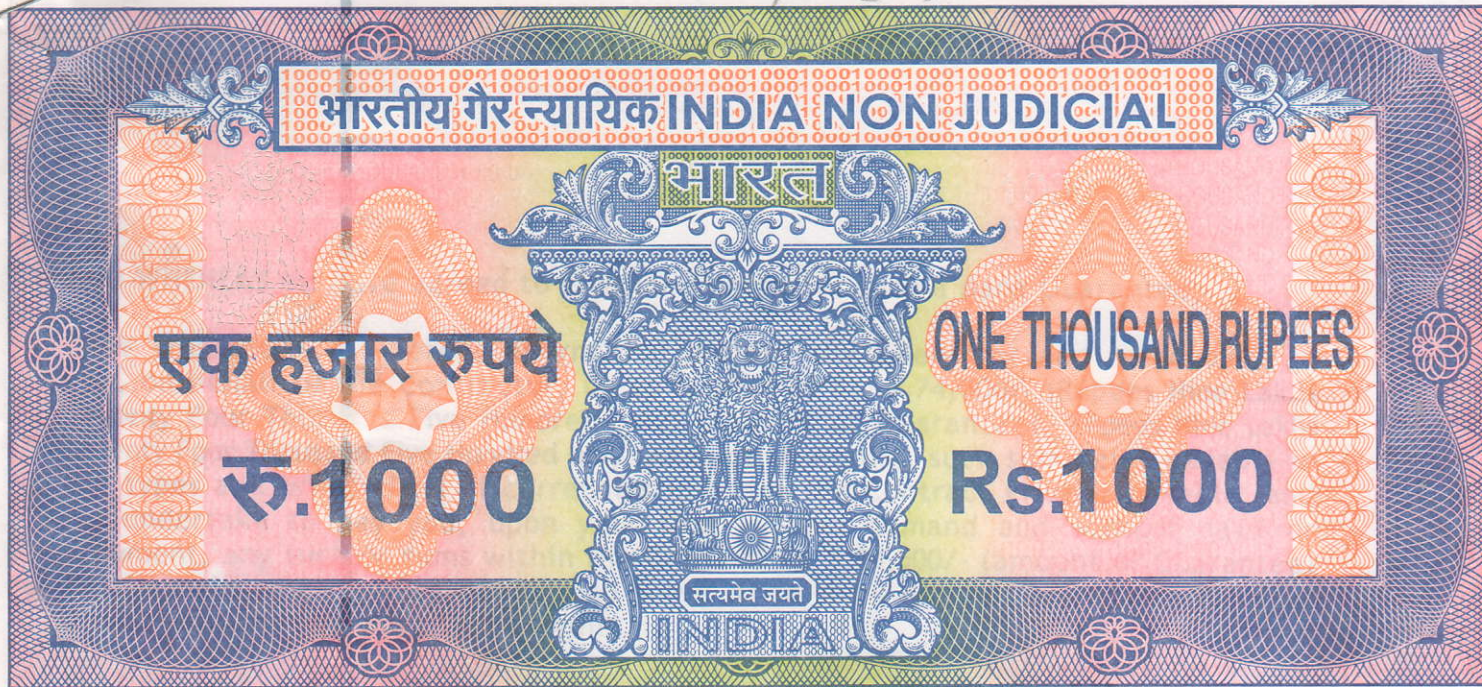

We further agree that no change or addition to or other modification of the term of the Contract or of the Works to be performed there under or of any of the Contract documents which may be made between you and the Contractor shall in any way release us from any liability under this guarantee, and we hereby waive notice of any such change, addition or modification.

This guarantee shall be valid upto 06.01.2020 (a date 45 days after the lapse of Defect Liability Period)

Notwithstanding anything contained herein

- (i) Our liability under this Bank Guarantee shall not exceed Rs. 9,74,500/- (Rupees Five Laks Forty Four Thousand only)
- (II) This Bank Guarantee is valid upto 06.01.2020 and
- (iii) We are liable to pay the guaranteed amount or any part thereof under this Bank Guarantee only and only if you serve upon us a written claim or demand on or before 06.01.2020 (mention period of the guarantee as found under clause (ii) above plus claim period)
