3. And whereas we SBT, Raxaul. (the Contractor) and with the intent to bind the bank, its successors and assigns do hereby unconditionally and irrevocably undertake to pay to the Corporation forthwith on first demand without protest or demur or proof or satisfaction and without reference to this guarantee upto to an aggregate limit of Rs. 4,86,000/-
4. 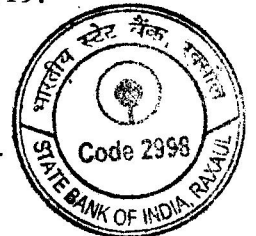
