Depositors must not keep specimen signatures in the passbook.

Depositors must check balance after transaction written in the passbook and contact postmaster immediately in case of any discrepancy.

In case of loss of passbook, report the matter in writing to the postmaster immediately.

Depositors must notify change of address if any to the postmaster.

Depositors must hand over blank signed withdrawal forms to any authorized agent including authorized agents.

Depositors must not appoint postmasters or authorized agents as messengers for withdrawal of money from their account.
