WHEREAS M/S Bolbum Constructions, Dharamganj, Kishanganj [name and address of Contractor] (hereafter called "the Contractor") has undertaken, in pursuance of Contract No. \_\_\_\_\_ dated \_\_\_\_\_ to execute Construction of Road and CD Works with maintenance for tender group 11 PMGSY 45 in East Champaran Package No. BR- 11R- 569, BR- 11R- 572, BR- 11R- 574 [name of Contract and brief description of Works] (hereinafter called "the Contract").

AND WHEREAS it has been stipulated by you in the said Contract that the Contractor shall furnish you with a Bank Guarantee by a recognized bank for the sum specified therein as security for compliance with his obligation in accordance with the Contract;



**AND WHEREAS** we have agreed to give the Contractor such a Bank Guarantee :

**NOW THEREFORE** we hereby affirm that we are the Guarantor and responsible to you on behalf of the Contractor, up to a total of **Rs. 6,80,000/-** [amount of guarantee] **Rupees Six Lac Eighty Thousand Only** (in words), such sum being payable in the types and proportions of currencies in which the Contract Price is payable, and we undertake to pay you, upon your first written demand and without cavil or argument, any sum or sums within the limits of **Rs. . 6,80,000/-** [amount of guarantee] as aforesaid without your needing to prove or to show grounds or reasons for your demand for the sum specified therein.

The guarantee will not revoked during its currency without the prior consent of the beneficiary.

We hereby waive the necessity of your demanding the said debt from the contractor before presenting us with the demand.

We further agree that no change or addition to or other modification of the terms of the Contract or of the Works to be performed there under or of any of the Contract documents which may be made between you and the Contractor shall in any way release us from any liability under this guarantee, and we hereby waive notice of any such change, addition or modification.

This guarantee shall be valid Upto 14/11/2020 (a date 45 days after the lapse of Defect Liability Period).

**"Not withstanding anything contained there in;**

- i) Our liability under this Bank Guarantee shall not exceed **Rs. . 6,80,000/- (Rupees Six Lac Eighty Thousand Only)**
- ii) This Bank Guarantee shall be valid upto 14/11/2020 and;
- iii) We are liable to pay the guarantee amount or any part, there of under this Bank Guarantee only if you serve upon us a written claim or demand on or before (date of expiry of Guarantee i.e. 14/11/2020).
