PERFORMANCE BANK GUARANTEE (UNCONDITIONAL)

The guarantee will not be revoked during its currency without the prior consent of the beneficiary.

We hereby waive the necessity of your demanding the said debt from the contractor before presenting
us with the demand.

We further agree that no change or addition to or other modification of the terms of the Contract or of
the Works to be performed there under or of any of the Contract documents which may be made
between you and the Contractor shall in any way release us from any liability under this guarantee, and
we hereby waive notice of any such change, addition or modification.

This guarantee shall be valid Upto 07.02.2020 (a date 45 days after the lapse of Defect Liability Period).

"Notwithstanding anything contained there in;

- i) Our liability under this Bank Guarantee shall not exceed **Rs. 2,50,000/- (Rupees Two Lac Fifty Thousand Only)**
- ii) This Bank Guarantee shall be valid upto **07.02.2020** and;
- iii) We are liable to pay the guarantee amount or any part, there of under this Bank Guarantee only
if you serve upon us a written claim or demand on or before (date of expiry of Guarantee i.e.
07.02.2020).
