

General Instruction

1. Passbook is a record of transactions for the information of the depositor and balance shown in it cannot be claimed legally.
2. It is the duty of the depositor to confirm balance shown in the passbook from the concerned post office and post office is legally liable to pay the amount actually available in its record.
3. Always take a printed receipt from the post office when you hand over the passbook for any purpose.
4. Always keep the passbook in safe custody and do not let it be lost. If lost, the office will not be responsible for the money in case the passbook is handed over to any other person.
5. Do not keep spare passbook.
6. Check balance regularly and report any discrepancy to the postmaster immediately.
7. In case of loss of passbook, the depositor should report to the postmaster immediately in writing to the postmaster.
8. Intimate change of address to the postmaster.
9. Do not hand over blank signed withdrawal forms to any person including authorized agents.
10. Do not appoint postmasters or authorised agents as messengers for withdrawals of money from your account.

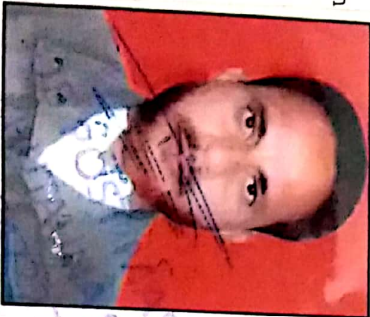
