## **BANK GUARANTEE**

WHEREAS. VINOD KUMAR, AT- LASANPUR, POST+P.S.- DAGARUA, DIST.- PURNEA, (BIHAR) Hereinafter called "the Contractor" has undertaken in pursuance of contract Singhia Road No-10 To Singhia Bhakta Tola Under (GTSNY)

We further agree that no charge or addition to or other modification of the contract or of the works to be performed there under or of any of the contract documents which may be made between you and the contractor shall in way release us from any liability under this guarantee, and we hereby waive notice of any such change, addition of modification.

This Guarantee shall be valid upto 15.02.2021

Not with standing any think contained herein:-

- Our liability under this Guarantee shall not exceed Rs. 2,00,000/- (Two lakh only)
- (ii) The Guarantee shall be valid upto 15.02.2021
- (iii) Our liability to make payment shall arise & we are liable to pay the guarantee only if you serve upon us a written claim or demand in terms of the guarantee on before \$15.02.2021
