This guarantee shall be valid up to 08.03.2020 (excluding claim period) from the date of expiry of the Defect Liability Period.

Our Liability under this Bank guaranty shall not exceed Rs. 22,65,500/-
This Bank Guarantee shall be valid up to 08.03.2020.
